² Correct accommodation for all participants. The invited folk groups will reside in different accommodations.

² Cover the cost of show production on adapted and equipped premises.

P One or two guides / translators.

What the Festival expects from your group:

The group includes at least 25 people including 21 artists or a maximum of 30 people including 26 artists.

² The group must be accompanied by musicians.

It To have a sufficient experience to participate in internationally renown event. Have a varied program (total time minimum 90 minutes).

Provide transport (bus) of your group for the trips during the festival as well as provide your own transport from your country.

A performance in a "partner" town.

Maximum mileage conducted of about 500 kms (trips between accommodation and stage and trips to "partner" towns).

Dundertake, if necessary, steps to get the Schengen visa and meet the costs of it.

Insurance covering all risks during the stay and meet the cost. (Once entering the French territory.)

^D Upon your arrival a refundable deposit may be requested. It will be returned on your departure if no damage found to the premises of your stay.
